TERMS AND CONDITIONS FOR CLIENT(S) & COSIGNER(S)

I. CLIENT & COSIGNER(S) INFORMATION

- A. Client & Cosigner(s) will give Company true and correct information on the application.
- B. Client & Cosigner(s) agrees that if the application is falsified in any way, the Client will forfeit his rights under this contract for bail bond and may at the Company's **option** be returned to jail with loss of the bond fee which has been paid to the Company.
- C. Client & Cosigner(s) shall provide all information requested on the application, and agrees that the Company may verify all such information supplied, and Client & Cosigner(s) duly consents to the release of any information supplied from doctor, attorney, governmental agency, credit bureau, etc., and shall release and hold harmless from liability any such entity supplying the Company with such verifying information.
- D. Client & Cosigner(s) may be required at anytime to report in person to update or answer any information required by the Company.

II. CLIENT & COSIGNER(S) REQUIREMENT FOR REPORTING

A. Client must report in every week. Client & Cosigner(s) must notify the Company if any of the following information **changes**:

1. **Home address and/or telephone number.** 2. **Employer's name, address, and / or telephone number.**

3. **Attorney's name, address and/or telephone number.**

- B. Client may be required to report in person or by telephone more than twice a week and may change at **discretion** of Company.
- C. **YOU ARE NOT TO LEAVE BEXAR-COMAL-_____ COUNTY FOR ANY REASON** without letting us know in advance. You must obtain permission, you must provide us with an address, phone number, city, state, with whom you are going to be with, and when you are coming back.

- E. **REPORT IN PERSON AT 1511 W. Martin SATX 78207 WEDNESDAYS _____ till final written disposition.**

III. CLIENT'S & COSIGNER(S) REPORTING OF COURT SETTING:

- A. Client may receive a copy of court setting upon release from jail or court and must provide it to Company.
- B. If for any reason, Client does not receive a court date, the Client must report to the Company, as required, until a court date is given. However, **Ultimately it is the duty of Client & Cosigner(s) to be aware of all court dates.**
- C. Client will faithfully **appear in person** at the Court on the day and time specified and place instructed by the Judge of the Court, whether or not notice is received from the Company, and remain there until the case is reset, dismissed, tried, or otherwise disposed of.
- D. Client must report to the Company after each and every court setting.
- E. In the event of a bond forfeiture, **YOU ARE ADVISED that BOND JUMPING is a criminal offense in the State of Texas and WE DO FILE BOND-JUMPING CHARGES** against clients who **CHOOSE** to forfeit their bond(s). We have a team of Experienced Criminal Investigators to recover those who choose to forfeit their bond(s). We never give up.

IV. CLIENT REPORTING ON RE-ARREST OR NEW CHARGES:

- A. Client agrees that in the event of arrest for new or additional charge(s), Client & Cosigner(s) will contact the Company immediately and provide a location & phone number of arrest location.
- B. In the event Client fails to report any re-arrest or new charges, it will be considered a breach of this contract and Client will forfeit all rights hereunder and Client will be returned to jail and fully liable as set forth in item V.

V. INDEMNIFICATION AND PAYMENT OF BOND PREMIUM:

- A. In addition to the terms and conditions, Client and/or Cosigner(s), agree that he/she/they will pay to the Company _____ Dollars in cash, as the Company's fee for making bail bonds previously set forth herein and that in the event that the Client **fails to appear** at his/her court setting, as instructed by the Company, and/or the Court forfeits the bail bond made on Client's behalf, and the Company becomes liable thereon to any law enforcement agency, Client & Cosigner(s) will indemnify the Company and will be liable for the full face amount of the bond plus Court costs, attorney's fees and fees incurred by the Company as direct or indirect result of said failure to appear or forfeiture.
- B. In the event a bond forfeiture has occurred, as previously set forth in Paragraph "A" hereof, and Client & Cosigner(s) have pledge or given any items of personal or real property as security to guarantee the faithful performance by Client under said bail bond, Client & Cosigner(s) agree that the Company may take any of the following action with said property, to wit: (1) sell said property and apply the proceeds thereof to reduction of Client's & Cosigner(s) indebtedness to the Company and the cost of the sales; (2) hold said property until Client & Cosigner(s) have fully paid the indebtedness to the Company as previously set forth and storage charges incurred. The Client & Cosigner(s) further agrees any and all necessary documents to fully perform under the terms hereof. Client & Cosigner(s) further agrees that in the event the security (if any) is insufficient to cover the full amount of the indebtedness plus other charges as set forth herein, and after all credits and offset have been allowed, the Company must seek judgment against Client & Cosigner(s) for any remaining unpaid balance due plus interest, court cost and attorney fees. I/We, referred to herein as Client & Cosigner(s), have read, understand and do agree to all of the terms and conditions as set forth in this agreement and do agree to fully abide by said terms and conditions in return for the Company making the bail bond(s). I/We fully understand that if Client does not abide by the terms and conditions thereof, Client will or may be placed back in jail at the option of the Bonding Company, and if taken into custody I/We agree to hold harmless the Bonding Company and its designated agent(s) from any civil claims or liability.
